#### **GENERAL RULES AND REGULATIONS**

##### **1. Eligibility**

**NO PURCHASE NECESSARY.**

This Contest is open to legal residents of Canada, excluding residents of Quebec. ##### **4. Contest Period**

Contest runs November 1 – November 30, 2022. All entries must be received by 1:00 p.m. (central standard time) on the advertised deadline date of the Contest, Monday, December 12, 2022.

Draws will be made on December 16, 2022 Contest winners will be announced and posted on Foundations' website by Wednesday, December 16, 2022.

#### 4. Prize

Prizes must be accepted as awarded and no cash equivalent is available. NO SUBSTITUTION OF PRIZES IS PERMITTED EXCEPT BY FOUNDATIONS OR CONTEST SPONSOR, CONEXUS CREDIT UNION, IN ITS SOLE DISCRETION. FOUNDATIONS/CONTEST SPONSOR, CONEXUS CREDIT UNION, RESERVES THE RIGHT TO SUBSTITUTE ANY PRIZES WITH ANOTHER PRIZE OF EQUAL OR GREATER VALUE. ##### **Random draws:**
